

STATE OF MICHIGAN COUNTY OF NEWAYGO BOARD OF COMMISSIONERS

At a regular session of the said Board held in the City of White Cloud, in said County, on the 18th day of March 2020, the following Resolution was adopted:

RESOLUTION #03-004-2020 ABOLISHMENT OF THE OFFICE OF THE COUNTY SURVEYOR

WHEREAS, the office of the Newaygo County Surveyor is an established elected office of Newaygo County Michigan; and

WHEREAS, pursuant to Section 203 of Act 116 of 1954, the Michigan Election Law, MCL 168.203, the current term of office of the Newaygo County Surveyor began on January 1, 2016, and continues through December 31, 2020; and

WHEREAS, the Revised Statutes of 1846, Chapter 14, MCL 54.95, Sec. 95, allows for the abolishment of the office of County Surveyor by resolution of the Board of Commissioners before May 15 of the year in which county officers are elected; and

WHEREAS, pursuant to MCL 54.95, the action to abolish the office of County Surveyor shall not shorten the current term of office of the County Surveyor; and

WHEREAS, Act 345 of 1990, the State Survey and Remonumentation Act ("Act 345"), requires each county to establish a county monumentation and remonumentation plan and perpetual monument maintenance plan; and

WHEREAS, Section 9 of Act 345, MCL 54.269, authorizes the County Board of Commissioners in counties without the office of County Surveyor to appoint a licensed professional surveyor to perform the duties of the County Representative for all surveying projects approved or initiated under Act 345; and

WHEREAS, the County Board of Commissioners for the County of Newaygo has determined that it is in the best interests of the public health, safety and welfare of the County residents to abolish the office of the Newaygo County Surveyor.

THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Newaygo County Michigan as follows:

- 1. The Office of the Newaygo County Surveyor is hereby abolished.
- 2. The current term of office of the Newaygo County Surveyor is not shortened by this action.
- 3. Any resolution inconsistent with this Resolution is hereby rescinded.
