2020-2021 PROPOSED AGRICULTURE & TOURISM PLATFORM

FARMLAND PRESERVATION

MAC supports:

- the state of Michigan providing greater leadership, including increased funding, in permanently preserving agricultural land. The Michigan Agriculture Environmental Assurance Program (MAEAP) certification should be a component of the preservation of farmland.
- the Department of Natural Resources working with agricultural producers to promote the utilization of state-owned land for agricultural production either through leasing of the land or sale of the land to producers.
- state funding for the Conservation Reserve Enhancement Program (CREP).

PURCHASE DEVELOPMENT RIGHTS PROGRAM

MAC supports:

- utilizing all farmland preservation tools or resources that are available, and exploring options for new preservation methods.
- appropriate and sufficient funding from the State to support this program.

CONSERVATION DISTRICTS

• the Legislature restoring historical funding to local Conservation Districts and Michigan State University Extension to assist with the preservation of agricultural lands and natural resources.
