## PRESS RELEASE

Kalkaska County Board of Commissioners have, at the Regular Meeting, March 18, 2020, reviewed recommendations from the District Health Department #10, MDHSS, CDC and Kalkaska County Emergency Management, in an effort to mitigate the spread of COVID-19.

In order to implement measures to slow the spread of the potential virus, and minimize the burden to our health care providers, and maintain the health and safety of our employees and community members, Kalkaska County will close the County buildings to the general public effective March 19, 2020 at 5:00 PM.

The county employees will report to work as normal.

All business will be conducted via postal mail, email, fax or phone.

Appointments may be made at the discretion of the Department Head.

This closure will be reviewed no later than March 30, 2020.
