

November 2022 County Millage Proposals

Alcona County

- 1.25 mill for Alcona County Emergency Medical Services. New tax is proposed for 4 years.

Arenac County

- 0.1 mill for the administration, services and financial aid to Veterans of Arenac County. New tax is proposed for 2 years.

Barry County

- 0.2191 mill for operation and maintenance of historic Charlton Park Village, museum, and recreation area. Renews current millage for 9 years.

Bay County

- 1.05 mill for operation and capital improvements to 911 Central Dispatch. Increases current millage of 0.7 mills by 0.35 mills for 6 years.
- 0.70 mills for Animal Services and Adoption Center. New tax is proposed for 6 years.
- 0.0996 mill for suppression of Gypsy Moths and other invasive species. Renews current millage for 6 years.
- 0.85 mill for Bay County Department of Aging. New tax replaces current millage of 0.55 mills by 0.3 mills for 6 years.
- 0.7476 mill for operation, maintenance, and capital costs of the Bay Medical Care Facility. Renews current millage for 6 years.

Berrien County

- 0.45 mill for public safety services. New tax is proposed for 5 years.

Branch County

- 0.99 mill for Maple Lawn Medical Care Facility. New tax is proposed for 5 years.

Chippewa County

- 8.0 mill for renewal and allocation of operating funds. County of Chippewa (6.15 mill), Townships (1.65 mill), and Intermediate School District (0.20 mill) for 4 years.

Eaton County

- 0.5 mill for parks and open spaces. New tax is proposed for 10 years.

Genesee County

- 0.0984 for providing support and assistance for veterans and their dependents and administrative and facility costs. Renews current millage for 9 years.

Grand Traverse County

- 0.5 mill for County Commission on Aging. Renews current millage for 10 years.

- 0.12 mill to operate County Veterans Affairs Office. Renews current millage for 6 years.
- 0.037 mill for County Animal Control Agency. New tax is proposed for 6 years.

Huron County

- 0.4 mill for E911/Central Dispatch system. New tax is proposed for 5 years.

Iosco County

- 1.3 mill for operational costs of County Jail and Prosecuting Attorney's Office. New tax is proposed for 6 years.

Iron County

- 1 mill for ambulance services. New tax is proposed for 4 years.
- 0.5 mill for operation and improvement of Youth Camp (Camp Ba-Ta-Wa-Ga-Ma) on Indian Lake. Renews current millage for 4 years.

Jackson County

- 1 mill for jail addition and sheriff's office. New tax is proposed for 20 years.
- \$3 per month for the funding of 9-1-1 emergency telephone call answering and dispatch service.

Kalamazoo County

- 4.85 mill for county operating expenses. Increases current millage of 4.6318 mill by 0.2182 mill for 20 years.

Lapeer County

- 1.85 mill for repair, maintenance, and improvement of existing roads and bridges. New tax is proposed for 4 years.

Lenawee County

- 0.1896 mill for operation and maintenance for the Lenawee Medical Care Facility. Renews current millage for 6 years.

Livingston County

- 0.1127 mill for county veteran services program. Renews current millage for 6 years.

Luce County

- 0.4985 mill for the Luce County Animal Shelter. Renews current millage for 5 years.
- 1.5 mill for ambulance services. Renews current millage for 5 years.

Macomb County

- 0.069 mill for Veteran Affairs. Renews current millage for 4 years.

Ogemaw County

- 0.7494 mill for 911 central dispatch services. New tax is proposed for 5 years.

Ontonagon County

- 0.2 mill for Veterans Association van financing and general operating. New tax is proposed for 1 year.

Otsego County

- 0.35 mill for recycling drop-off program. Renews current millage for 5 years.

Roscommon County

- 4.6 mill for general government operating purposes; restoring rate that existed prior to Headlee rollbacks.

Saginaw County

- Increases current mosquito abatement millage of 0.64 mills to 1.0 mills for 20 years.

Sanilac County

- 0.2 mill for Sanilac County Medical Care Facility. Renews current millage for 6 years.

Schoolcraft County

- 1.5 mill for operation and maintenance of the Schoolcraft County Medical Care Facility. Renews current millage for 10 years.
- 0.62 mill for Manistique Senior Citizens Center. New tax is proposed for 5 years.

Shiawassee County

- 0.1956 mill to provide services to Shiawassee County Veterans of Active, United States Military service and their dependents. New tax is proposed for 6 years.

Tuscola County

- \$44,000,000 for new county jail and sheriff's facility bond. Not to exceed 30 years.
