Cherry, Tisdel to receive MAC Advocate Awards

During breakfast on Wednesday, April 9, MAC will honor two state legislators with County Advocate Awards for their work in 2024:



Cherry

Sen. John Cherry is in his first term in the Michigan Senate, where he chairs the Labor Committee and serves on the Appropriations Committee. Prior to his Senate term, he served two terms in the Michigan House of Representatives. Before arriving in the Legislature, Cherry served in the Michigan Department of Natural

Resources and held the position of vice chair of the Flint Charter Commission. He is a University of Michigan graduate with a bachelor's degree in natural resources and environment and a master's in public policy.

Cherry is being honored for spearheading a \$30 million increase to county revenue sharing for FY 2025. "His research and dedication to a formula for disbursement of these additional funds created a system of greater equity among counties," explained MAC Governmental Affairs Director Deena Bosworth. "Without his commitment to counties and his strong advocacy with other legislative leaders, counties would not have seen the additional \$30 million in FY25."



Tisdel

Rep. Mark Tisdel has represented the Greater Rochester in the Michigan House of Representatives since 2021. He chairs the House Finance Committee and is vice chair of the House Insurance Committee. He also serves as a member of the House Health Policy Committee and the House Regulatory Reform Committee.

Prior to his service in the Legislature, Tisdel served on the Rochester Hills City Council for eight years — four of those years as council president.

"Tisdel has been a consistent bill sponsor and outspoken advocate for the creation of a Revenue Sharing Trust Fund," said Bosworth. "He not only was responsible for the overwhelming support of the bills in the House last session, but he worked tirelessly with the Senate, MAC and the Governor' Office to take the bills up for a vote last session. Unfortunately, the Senate did not end up voting on the bills during lame duck, so he is taking up the mantel again this year."




